The special meeting was called to order at 5:00 PM by Chairperson Skelton.

Attendance:

Chairperson Skelton, Commissioner Gartland, Commissioner Wise, Commissioner Weaver, Secretary/ Treasurer Zubrzycki, Chief Stavalone, Asst. Business Manger Ben Skelton, and Battalion Chief Dewitt, Lieutenant MTO O'Neal.

Pledge: The pledge of allegiance was led by Commissioner Wise.

Chairperson Skelton opened the special meeting to accept and formally award bids for four categories in the building process of the Training Facility.

New Business:

Chairperson Skelton moved to accept the bid for General Trades. There were four bid proposals received for this category, the lowest of which being UDN Inc. This bid proposal was to the amount of \$1,249,777.00. UDN Inc was descoped by Christa Construction on December 19th. A motion was requested to accept the bid proposal from UDN Inc. The motion was made by Commissioner Wise and seconded by Commissioner Gartland. This motion was passed 4-0.

Chairperson Skelton moved to accept the bid for Plumbing and Fire Protection. There were four bid proposals received for this category, the lowest of which was LMC Industrial Contracts. This bid proposal was to the amount of \$465,750.00. LMC Industrial Contracts was descoped by Christa Construction on December 22nd. A motion was requested to accept the bid proposal from LMC Industrial Contracts. The motion was made by Commissioner Wise and seconded by Commissioner Weaver. This motion was passed 4-0.

Chairperson Skelton moved to accept the bid for Electrical Work. There were six bid proposals received for this category, the lowest of which being Kaplan-Schmidt Electric Inc. This bid proposal was to the amount of \$289,000.00. Kaplan-Schmidt Electric Inc. was descoped by Christa Construction on December 19th. A motion was requested to accept the bid proposal from Kaplan-Schmidt Electric Inc. The motion was made by Commissioner Gartland and seconded by Commissioner Wise. This motion was passed 4-0.

Chairperson Skelton moved to accept the bid for Mechanics for Training Facility. There were four bid proposals received for this category, the lowest of which being Tactical Construction Inc. This bid proposal was to the amount of \$133,941.25. Tactical Construction Inc has not yet been descoped by Christa Construction. A motion was requested, contingent upon a positive descoping by Christa Construction, to accept the bid proposal from Tactical Construction Inc. The motion was made by Commissioner Gartland and seconded by Commissioner Wise. This motion was passed 4-0.

The amount of the accepted bid proposals in totality is \$2,138,468.25.
